RULES AND PROCEDURES

- All prices on this form and all paybacks are in US Dollars.
- Registration Requirements: Halter Classes are open to horses registered with AQHA only. Performance Classes are open to horses registered with AQHA, APHA, PHBA or ApHC.
- AQHA & NSBA rules apply.

- Ownership Requirements:
WNYQHC: All Owners must hold current membership in the Western New York Quarter Horse Club or pay Non-Member Fee. If a horse has multiple owners, each owner must be a WNYQHC member or pay a single Non Member Fee of \$25. WNYQHC membership fees are \$20 Individual and \$25 Family.

NSBA: For NSBA classes, both Owner and Exhibitor must be members of NSBA or pay the NSBA membership fee with entry. If you do not wish to be an NSBA member, you may purchase an NSBA Show Pass for \$10.

- Date of Entry is determined by the U.S. or Canadian Postmark.
- Go-Rounds: All Futurity Classes consist of one go-round on the date indicated, two judges.
- Weanling & Yearling Halter Classes will be run with the corresponding AQHA class where possible. You are required to enter the AQHA class to show in the Futurity.
- Purse Money: Purse is comprised of the Added Money plus 80% of All Entry Fees + Late Fees. Payback checks will be mailed after the show, provided that all checks for entry payments & stalls have cleared the bank. Any money owed to WNYQHC for horse show entries, stalls, futurity entries, etc. (or for any other reason) will be deducted from futurity purse money, along with all charges for NSF checks.

Payback percentages are: 1 entry – 100%; 2 entries – 60%, 40%; 3 entries – 45%, 35%, 20%; 4 entries – 40%, 30%, 20% 10%; 5 entries – 34%, 27%, 20%, 10%, 9%; 6 or more entries – 32%, 22%, 19%, 10%, 9%, 8%.

- Ties: A tie-breaker judge will be announced to break all ties.
- No substitutions are allowed and there will be no refunds given for any reason.
- Entries will be accepted at the show up to one hour before the class at the higher entry fee. Office Fees associated with the Candy Apple Classic will apply to futurity entries. See the Show Office to receive your number and pay your Office Fee at the show.
- By submitting entries, owner and exhibitor agree that WNYQHC, Hamburg Fairgrounds and the Erie County Agricultural Society are not responsible for any loss, damage or injury to any horse, exhibitor, or article of any kind.
